RESOLUTION TO AUTHORIZE THE HEALTH COMMISSIONER TO ENTER INTO A CONTRACT WITH MIGHTY CROW MEDIA IN SUPPORT OF THE CENTERS FOR DISEASE CONTROL AND PREVENTION (CDC) OVERDOSE DATA TO ACTION (OD2A) GRANT FOR THE PURPOSE OF PROVIDING PROGRAMMATIC, STRATEGIC, AND ANALYTIC CONSULTATION TO THE COLUMBUS PUBLIC SAFETY DIVISION RREACT TEAM REGARDING DATA COLLECTION AND SURVEILLANCE SYSTEM DESIGN AND IMPLEMENTATION. (EXPENSE NOT TO EXCEED \$40,000.00)

**WHEREAS**, Franklin County Public Health (FCPH) has been awarded a grant from the CDC and is actively involved in the creation of an Opioid interactive surveillance system (CARES); and

**WHEREAS**, Franklin County Public Health (FCPH) seeks to collaborate with Mighty Crow Media as a member of the OD2A Advisory Committee to consult with Columbus Public Safety Division, RREACT on data collection, analysis and evaluation for the purpose of obtaining and downloading the data into the CARES database; and

**WHEREAS**, Mighty Crow Media will support the data evaluation & analysis, specific to the CDC OD2A reporting needs with a focus on the efforts of the CDC funded RREACT outreach team within the FCPH jurisdiction

**WHEREAS**, with this grant Mighty Crow Media will support updates to the Emergency Network RREACT module to increase capacity for the RREACT data collection with regards to CDC OD2A Data Advisory Group
