Health Commissioner's Report/Occumetrics Update - Joe Mazzola -

Commissioner presented an update on Occumetrics and monthly Health Commissioner report and shared that the Occumetrics report will be posted on Portal. See attached.

Medical Director's Report – Dr. Miller Sullivan – influenza season is coming to an end; COVID is on an uptick with possible variants forthcoming; 82 million cases documented and 1 million deaths in the U.S., with 83% vaccinated. Lack of baby formula continues to worsens. Fear that parents will begin to make substitutes/alternatives to their babies that may harm them. Hepatitis cluster in younger children (2 years old) liver disease without a known cause.

Legal Counsel's Report – Joe Durham, Esq. – Joe Durham reported that he participated in a meeting with Jeanine Hummer, First Assistant Prosecuting Attorney and Chief Counsel of the Franklin County Prosecuting Attorney's Office Civil Division and the City Manager and Law Director for the City of New

Albany. The discussion addressed the legalities of a proposal by New Albany to revise the contract for health services with FCPH. The City indicated that no decisions have been made and that they are waiting on some more information.
