

RESOLUTION AUTHORIZING THE FRANKLIN COUNTY BOARD OF HEALTH TO PROVIDE PUBLIC HEALTH AND PLUMBING SERVICES TO POLITICAL SUBDIVISIONS IN 2023

WHEREAS, pursuant to Ohio Revised Code Section 3709.08, the Franklin County District Advisory Council and/or Franklin County Public Health may contract with political subdivisions located within or adjacent to the general health district of Franklin County, Ohio, for Franklin County Public Health to provide health and plumbing services to said political subdivisions.

BE IT RESOLVED BY THE FRANKLIN COUNTY BOARD OF HEALTH, BOARD MEMBERS;

1. That Franklin County Public Health shall provide such health and plumbing services as set forth in the attached contracts to the following political subdivisions, for the amounts listed below, as executed by the District Advisory Council and political subdivisions for 2023:

City of Bexley	per capita <u>\$9.5996</u> ; not to exceed <u>\$133,069.66</u> and 60% of all plumbing fees collected
City of Canal Winchester	per capita <u>\$9.5996</u> ; not to exceed <u>\$90,898.61</u> and 60% of all plumbing fees collected
City of Dublin	per capita <u>\$9.5996</u> ; not to exceed <u>\$472,501.91</u> and 60% of all plumbing fees collected
City of Gahanna	per capita <u>\$9.5996</u> ; not to exceed <u>\$343,147.30</u> and 60% of all plumbing fees collected
City of Grandview Heights	per capita <u>\$9.5996</u> ; not to exceed <u>\$77,545.57</u> and 60% of all plumbing fees collected

City of Grove City	per capita <u>\$9.5996</u> ; not to exceed <u>\$396,684.27</u> and \$100.00 per plumbing inspection and \$150.00 per medical gas inspection, as needed
City of Groveport	per capita <u>\$9.5996</u> ; not to exceed <u>\$57,415.21</u> and 60% of all plumbing fees collected
City of Hilliard	per capita <u>\$9.5996</u> ; not to exceed <u>\$356,087.56</u> and 60% of all plumbing fees collected
City of New Albany	per capita <u>\$9.5996</u> ; not to exceed <u>\$104,491.65</u> and 60% of all plumbing fees collected
City of Obetz	per capita <u>\$9.5996</u> ; not to exceed <u>\$52,692.20</u> and 60% of all plumbing fees collected
City of Pickerington	per capita <u>\$9.5996</u> ; not to exceed <u>\$224,582.64</u> and 60% of all plumbing fees collected
City of Reynoldsburg	per capita <u>\$9.5996</u> ; not to exceed <u>\$392,633.24</u> and 60% of all plumbing fees collected
City of Upper Arlington	per capita <u>\$9.5996</u> ; not to exceed <u>\$351,518.15</u> and 60% of all plumbing fees collected
City of Westerville	per capita <u>\$9.5996</u> ; not to exceed <u>\$375,949.13</u> and 60% of all plumbing fees collected
City of Whitehall	per capita <u>\$9.5996</u> ; not to exceed <u>\$194,430.30</u> and 60% of all plumbing fees collected

2. That the Health Commissioner is authorized to prepare and execute the following plumbing services contracts for 2023:

Village of Minerva Park	60% of all plumbing fees collected
City of Worthington	60% of all plumbing fees collected
Madison County	60% of all plumbing fees collected
