

RESOLUTION TO APPROVE THE ISSUANCE OF
CONSTRUCTION AND DEMOLITION DEBRIS
LANDFILL OPERATION LICENSES TO JDM
SERVICES LLC AND SCOTT WRECKING COMPANY
INC; AND THE ISSUANCE OF SOLID WASTE
LICENSES TO SOLID WASTE AUTHORITY OF CENTRAL
OHIO AND WASTE MANAGEMENT OF OHIO
TRANSFER AND RECYCLING CORPORATION

WHEREAS, Franklin County Public Health is authorized to license, inspect, and enforce sanitary standards for construction and demolition debris facilities pursuant to Ohio Revised Code 3714 and solid waste facilities pursuant to Ohio Revised Code 3734;

WHEREAS, JDM Services, LLC (dba: Frank Road Recycling Solutions) and Scott Wrecking Company, Inc. have each submitted an application for a Construction and Demolition Landfill License;

WHEREAS, the Solid Waste Authority of Central Ohio (SWACO) and Waste Management of Ohio Transfer and Recycling Corporation have each submitted an application for a Solid Waste Facility License; and

WHEREFORE, Jeff Gibbs, Environmental Health Division Manager, testified that: JDM Services LLC submitted a complete application and that the facility located at 2230 Brown Road, Columbus, Ohio, complies with the rules adopted under 3714.02 of the Ohio Revised Code; Scott Wrecking Company Inc. submitted a complete application and that the facility located at 1489 Harmon Avenue, Columbus, Ohio, complies with the rules adopted under 3714.02 of the Ohio Revised Code; Solid Waste Authority of Central Ohio submitted a complete application and that the facility located at 3851 London-Groveport Road, Jackson Township, Franklin County, Ohio, complies with the rules adopted under 3734 of the Ohio Revised Code; and Waste Management of Ohio Transfer and Recycling Corporation submitted a complete application and that the facility located at 1046 Walnut Street, Canal Winchester, Ohio, complies with the rules adopted under Chapter 3734 of the Ohio Revised Code.

Now, therefore, upon motion of Board Member _____, seconded by Board Member _____,

BE IT RESOLVED BY THE FRANKLIN COUNTY BOARD OF HEALTH, BOARD MEMBERS;

1. The Board approves the issuance of a 2023 license to operate a construction and demolition landfill to the following companies and locations: JDM Services LLC at 2230 Brown Road; Columbus, Ohio; and Scott Wrecking Company Inc. at 1489 Harmon Avenue; Columbus, Ohio.
2. The Board approves the issuance of a 2023 license to operate a solid waste facility to the following companies and locations: Solid Waste Authority of Central Ohio at 3851 London-Groveport Road; Grove City, Ohio; and Waste Management of Ohio Transfer and Recycling Corporation at 1046 Walnut Street; Canal Winchester, Ohio.
3. The Board directs the Health Commissioner to issue such license pursuant to Ohio Revised Code Chapter 3714 and 3734.
4. This resolution shall be in full force and effect from and immediately upon its adoption.
