

RESOLUTION 23-008

TO AUTHORIZE THE HEALTH COMMISSIONER TO PROVIDE SPONSORSHIP OPPORTUNITIES AND ACCEPT FUNDING FROM PARTNERS AND LOCAL COMMUNITY AGENCIES (CARESOURCE, and I AM BOUNDLESS) FOR THE 2022 ANNUAL CHAT SUMMIT. (Revenue of \$1,000.00)

WHEREAS, Franklin County Public Health (FCPH) will host a 1-day in-person Summit to share with external partners the programming the Community Health Action Teams (CHATs) have accomplished, as well as showcasing the work and programs completed by other sections of FCPH; and

WHEREAS, On Tuesday, January 24, 2023, FCPH will host "2022 CHAT Summit: CommYOUnity: Bridging Health Gaps Across Franklin County Summit" to explore the roots of inequality and discrimination. This presentation will be provided by Dr. Jason Reece, Associate Professor for City and Regional Planning in the Knowlton School. Dr. Reece is also a faculty affiliate at The Kirwan Institute for the Study of Race & Ethnicity. His work broadly focuses on social equity and justice in the context of planning history, theory and practice. More specifically, his research seeks to understand the role of planning in fostering a built and social environment which supports a just city and healthy communities; and

WHEREAS, Staff of FCPH will facilitate table discussions, an activity known as a "World Café" and engage external partners on new ideas and suggestions on community engagement. The purpose is to understand and hear from the community the importance and experience community engagement has on them personally and professionally, while providing FCPH staff an opportunity to connect with new partners to strengthen their programs and understanding of how to engage equitably; and

WHEREAS, FCPH has decided NOT to charge an attendance/registration fee for the Summit and will provide meals for individuals on site. Due to the cost associated with hosting such a quality event, various partners would like to co-sponsor and contribute to this event by assisting in covering some of the day's costs.
