**WHEREAS**, data and information collected, analyzed and communicated from the cultural climate assessment and resulting recommendations will help inform ongoing organizational equity focused efforts as supported by the FCPH one goal of "Equity" as the foundation for conducting the daily work of the agency and as its North Star; and assist in the continued execution of the FCPH Declaration of Racism is a Public Health Crisis.
