ORDER OF THE BOARD OF HEALTH AND REFERRAL FOR PROSECUTION

Dear Galloway Apartments, LLC:

The tax and property records on file with the Franklin County Auditor's and/or Recorder's Office identify you as the owner of said properties. It was brought to the attention of this office that the nuisance has not been abated.

Pursuant to Ohio Revised Code Chapter 3707.01, the Franklin County Board of Health has authority to determine if a nuisance exists at the above-referenced properties. If the Board of Health declares a nuisance, you will be ordered to abate the nuisance conditions. On December 12, 2023, the Board of Health adopted Resolution 23-195, attached hereto and incorporated herein, ORDERING you to:

1. Abate the nuisance by removing trash and rubbish around the property and garbage receptacles.

This Order applies to you, your heirs, successors and assigns (including any subsequent owner of the property). You shall comply with this Order by January 12, 2024. A reinspection will be performed to verify compliance on or thereafter. IF THESE VIOLATIONS ARE NOT CORRECTED, and this Order of the Board is neglected or disregarded, the Board has authorized me to issue a citation pursuant to Ohio Revised Code section 3707.02 and afford you an opportunity to appear before the Board and show cause why the Board should not abate the nuisance conditions (assessing the costs of any abatement as liens against the properties). In addition, IF THESE VIOLATIONS ARE NOT CORRECTED, the Board has authorized me to refer this matter to the Franklin County Prosecuting Attorney which

may result in the filing of criminal charges or a request for injunctive relief in a civil lawsuit being filed in the Franklin County Municipal Court, Environmental Division. This Order may be appealed to the Board of Health by any person claiming to be aggrieved or adversely affected by requesting a hearing within seven (7) days of receipt of the Order. The request for a hearing shall be delivered to the Board of Health in writing and addressed to the attention of the Health Commissioner.
