Board of Health Order Appellate Hearing Summary & Recommendation

Sustainability and Nuisance

Current situation	Galloway Apartments has had consistent issues with trash piling up at the container sites. FCPH received initial complaint on December 19, 2022. Chris Copley spoke with property manager on 12/19/22 and completed initial observation on 12/30/22. There were piles of trash on the ground next to the containers still. Chris went back on January 9 th , no change. Jeff Grose completed the Registered Environmental Health Specialist inspection on the 9 th as well. In midst of investigations, Prairie Township abated the trash issues on 1/19/23 and subsequently again on 2/3/23 and has placed liens on the property. FCPH sent Notice of Hearing on 1/19/23. Property management has switched trash collectors, as they said that was the issue, however, trash solid waste nuisances continue to occur. Please see photos from 1/30/23, where there are already starting to be trash bags on the ground as well as This is a recurring issue. The issue was again abated in February. We have now received an updated complaint as of October 5 th , again of trash piling up. Jeff Grose inspected the site on 10/5/23 and found trash outside of the dumpster; at this time the Township was working with Waste Management to resolve the issue. On November 11 th , FCPH staff had a meeting with Jai Sneed, the regional manager of the property (among others) He stated that due to funding constraints they were initially focused on ensuring water, electricity and gas stayed on, but that they were working on the trash issues as well. On 11/19/23, Waste management removed all dumpsters from the site due to back fees and failure to pay. There are currently no dumpsters on site, this is a public health nuisance. Currently, Prairie Township is working withing their Nuisance Abatement Program as well as Environmental Court as well to abate the issue.
Requirements	Ohio Revised Code 3707.01 (B) states: "The board of health of a general health district shall abate and remove all nuisances within its jurisdiction. It may, by order, compel the owners, agents, assignees, occupants, or tenants of any lot, property, building, or structure to abate and remove any nuisance therein, and prosecute such persons for neglect or refusal to obey such orders";
