WHEREAS, Franklin County Public Health (FCPH) issued a Request for Application (RFA) to solicit proposals from EAC and CHAT members who submitted applications and met eligibility criteria to receive stipends not to exceed \$25,000 per organization;

WHEREAS, FCPH seeks to contract with the following organizations to support community mitigation, resiliency, or engagement strategies: The P.E.E.R Center, Godman Guild Association, National Council of Negro Women, Inc. Columbus, Cross Creek Village Association (Hilliard CHAT), Home on the Hill (Prairie Township Chat), Otterbein University (Westerville CHAT), Upper Arlington Community Foundation (Upper Arlington CHAT), Clinton Township (Clinton Township CHAT), and United Way of Central Ohio (Eastside and Canal Winchester CHATs); and

WHEREAS, stipend recipients will provide various programming to support mitigation, resiliency, and engagement strategies related to COVID-19, including education, community outreach events, materials and resources to reduce the spread of communicable disease and its effects on the health and safety of our communities.
