RESOLUTION TO AUTHORIZE THE HEALTH COMMISSIONER TO PROVIDE SPONSORSHIP OPPORTUNITIES AND ACCEPT FUNDING FROM PARTNERS AND LOCAL COMMUNITY AGENCIES (CARESOURCE and BUCKEYE HEALTH) FOR THE 2024 MINORITY HEALTH MONTH EVENTS. (TOTAL REVENUE \$598.00 - CARESOURCE (\$150.00) and BUCKEYE HEALTH (\$448.00))

WHEREAS, Franklin County Public Health (FCPH) will host a 2-day in-person events for Minority Health Month in Whitehall with funding from the Ohio Commission on Minority Health.

WHEREAS, On Saturday, April 6, 2024, FCPH will host "Cooking with Care" to provide the attendees with the knowledge and skills related to healthy eating and disease prevention and/or management. On Friday, April 26, 2024, will host "Eastside Family Wellness Fair" to provide attendees with health resources and health screenings. These events will be focused on reducing health disparities by promoting cardiovascular health, chronic disease prevention, and harm reduction. The targeted audiences for the events include people of color, adults, children, and seniors in Whitehall and Reynoldsburg.

WHEREAS, Staff of FCPH and community partners will provide community members with various resources through tabling vendors, health screenings and referrals. The purpose is to reduce health disparities through community engagement, health promotion and barrier reduction.

WHEREAS, FCPH has decided not to charge a registration fee for the Eastside CHAT events and hopes to provide snacks and drinks for individuals on site. Due to the restrictions of the funding from the Ohio Commission on Minority Health, food and beverage costs are not covered. As such, CareSource and Buckeye Health would like to sponsor and contribute to this event by assisting in covering some of the day's food costs.

WHEREAS, the Division of Health System and Planning engages with the community in support of PHAB Domain 3 to inform and educate about public health issues and functions, and Domain 4 to engage with the community to identify and address health problems.
