RESOLUTION TO AUTHORIZE THE HEALTH COMMISSIONER TO ENTER INTO A CONTRACT WITH MORROW COUNTY HEALTH DISTRICT FOR FY2024-2025 PUBLIC HEALTH EMERGENCY PREPAREDNESS (PHEP) & CITIES READINESS INITIATIVE (CRI) GRANT BETWEEN JULY 1, 2024, TO JUNE 30, 2025 (REVENUE NOT TO EXCEED \$45,707.85 – PHEP & CRI GRANT FUNDING);

WHEREAS, FCPH and MCHD serve to protect the health, safety and well-being of the residents of their respective jurisdictions by providing quality public health services; MCHD has a need for a coordinator for PHEP and CRI, and FCPH has competent, experienced coordinator(s) with the capacity to provide such services; and

WHEREAS, Public Health Emergency Preparedness (PHEP) and Cities Readiness Initiative (CRI) dollars are Federal grant dollars to assist the health districts in meeting the preparedness needs. Deliverables requested by the Ohio Department of Health (ODH) in FY24/25 that FCPH will contract and work with Morrow County to complete: Statewide Integrated Preparedness Planning Workshop (IPPW), where FCPH and Morrow County will attend ODH IPPW to identify and discuss exercise program priorities that will advance both local and state preparedness, as well as planning and conducting a Chemical Tabletop Exercise (TTX) to demonstrate performance and capabilities of Morrow County response; and

WHEREAS, FCPH and MCHD have worked together for over 5 years and have successfully completed over 50 PHEP/CRI grant deliverables; including the successful execution of the 2023 statewide Regional Drop Site exercise, working with MCHD staff and Morrow County Emergency Management Agency (EMA) to complete Point of Dispensing (POD) drills, and hosting a Continuity of Operations (COOP) Tabletop exercise to test MCHD staff on how to continue operations at an offsite location; and

WHEREAS, this is the first year of a five year grant cycle for PHEP & CRI funding; and the identified emergency preparedness activities aligns with Franklin County Public Health PHAB accreditation measurement 5.4;
