RESOLUTION AUTHORIZING THE FRANKLIN COUNTY BOARD OF HEALTH TO PROVIDE PUBLIC HEALTH AND PLUMBING SERVICES TO POLITICAL SUBDIVSIONS IN 2025

WHEREAS, pursuant to Ohio Revised Code Section 3709.08, the Franklin County District Advisory Council and/or Franklin County Public Health may contract with political subdivisions located within or adjacent to the general health district of Franklin County, Ohio, for Franklin County Public Health to provide health, and plumbing and medical gas services to said political subdivisions.

BE IT RESOLVED BY THE FRANKLIN COUNTY BOARD OF HEALTH, BOARD MEMBERS;

1. That Franklin County Public Health shall provide such health, and plumbing and medical gas services as set forth in the attached contracts to the following political subdivisions, for the amounts listed below, as executed by the District Advisory Council and political subdivisions for 2025:

City of Bexley	\$10.1867 per capita; not to exceed. \$137,693.62 and 60% of all plumbing permit fees collected.
City of Canal Winchester	, \$10.1867 per capita not to exceed \$97,833.07; and 60% of all plumbing permit fees collected.
City of Dublin	\$10.1867 per capita; not to exceed. \$ 497,182.27 and 60% of all plumbing permit fees and 100% of plan review fees collected.
City of Gahanna	\$10.1867 per capita; not to exceed \$354,273.05 and 60% of all plumbing permit fees collected.
City of Grandview Heights	\$10.1867 per capita; not to exceed. \$85,262.68 and 60% of all plumbing permit fees collected.

City of Hilliard	\$10.1867 per capita; not to exceed \$383,413.20 and 60% of all plumbing permit fees collected.
City of New Albany	\$10.1867 per capita; not to exceed \$113,968.80 and 60% of all plumbing permit fees collected.
City of Obetz	\$10.1867 per capita \$; not to exceed \$54,233.99 and 60% of all plumbing permit fees collected.
City of Pickerington	\$10.1867 per capita \$; not to exceed \$253,883.12 and 60% of all plumbing permit fees collected.
City of Reynoldsburg	\$10.1867 per capita; not to exceed \$413.050.31 and 60% of all plumbing permit fees collected.
